GENERAL SUMMARY: Under general supervision, drive vehicle to work site location; assist Collection Operators, Mechanics, Plant Operators, and Treatment Plant personnel when required; perform general maintenance tasks at all facilities and buildings; assist with marking PA One Calls; assist with responding to customer complaints.

#### ESSENTIAL DUTIES AND RESPONSIBILITIES:

- 1. Drive light motor vehicle or small dump truck site locations in four (4) municipality regions covered by OASA.
- 2. Assist Collection Operators with routine operation and maintenance of OASA's collection system and pumping stations; e.g. assist with repair of broken or clogged sewer lines, under direction, set up display of safety signs at work site, flag traffic, lift manhole covers or manually unclog sewer lines and remove excess debris and grease; assist with wet well cleaning and tank cleaning as required.
- 3. Assist Mechanics with routine operation and maintenance of OASA's facilities and equipment; e.g. assist with equipment and vehicle maintenance when required, clean equipment and vehicles when required.
- 4. Assist Plant Operators and Treatment Plant personnel when required; e.g. assist with tank cleaning, equipment, and vehicle maintenance; clean equipment and vehicles when needed.
- 5. Perform general maintenance, grounds keeping, cleaning, and painting tasks at all of OASA's facilities and buildings; e.g. clear walks of snow and ice; mow grass and trim shrubs, remove weeds and debris; wipe down surfaces, sand surfaces, paint; sweep and mop floors as required, clean windows, dust surfaces, clean locker rooms and rest rooms.
- 6. Assist with marking PA One Calls.
- 7. Respond to complaints from public; explain services provided by OASA, report non-routine problems to Operations Supervisor.

### Knowledge:

- Advanced knowledge of safety practices and procedures. \*

- Ability to demonstrate clear vision and sound hearing to avoid possible hazards, including moving vehicles and road equipment.\*
- Ability to respond to emergencies on a 24-hour basis.
